## Fund objective

Bear ProFund seeks daily investment results, before fees and expenses, that correspond to the inverse (-1x) of the daily performance of the S&P 500® Index. The Fund does not seek to achieve its stated investment objective over a period of time greater than a single day.

## Fund performance and index history<sup>2</sup>

The Bear ProFund seeks daily investment results, before fees and expenses, that are -1x the return of the S&P 500® (the "Index") for a single day, not for any other period.

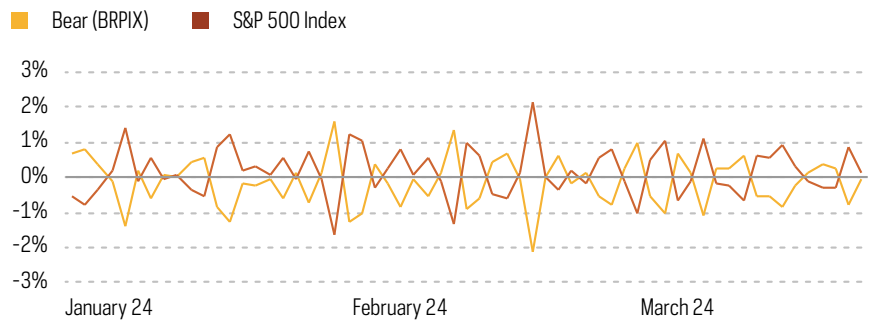


- Helping to hedge against declines
