- Overweighting a market segment without additional cash

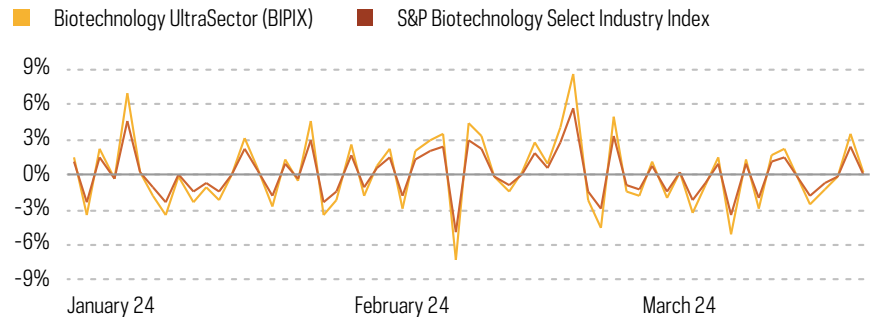

Daily return during 1Q 2024


