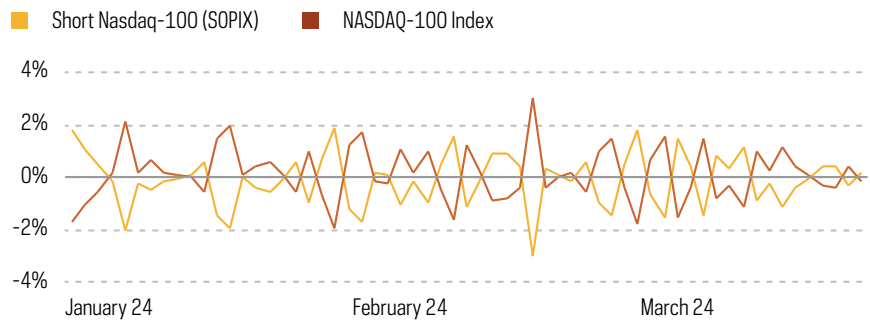

Daily return during 1Q 2024


