Fund objective

Financials UltraSector ProFund seeks daily investment results, before fees and expenses, that correspond to one and one-half times (1.5x) the daily performance of the S&P Financial Select SectorSM Index. The Fund does not seek to achieve its stated investment objective over a period of time greater than a single day.

The Financials UltraSector ProFund seeks daily investment results, before fees and expenses, that are 1.5x the return of the S&P Financial Select Sector IndexSM Index (the "Index") for a single day, not for any other period.



Common uses for magnified exposure include:


- Seeking magnified gains (will also magnify losses)

Narrowly focused investments typically exhibit higher volatility.

Many ProFunds seek daily investment results that correspond, before fees and expenses, to a multiple (e.g., 2x, -2x) of the daily performance of its underlying benchmark (the "Daily Target"). While these Funds have a daily investment objective, you may hold Fund shares for longer than one day if you believe it is consistent with your goals and risk tolerance. For any holding period other than a day, your return may be higher or lower than the Daily Target. These differences may be significant. Smaller index gains/losses and higher index volatility contribute to returns worse than the Daily Target. Larger index gains/losses and lower index volatility contribute to returns better than the Daily Target.
