- Overweighting a market segment without additional cash



Daily return during 4Q 2025



Many ProFunds seek daily investment results that correspond, before fees and expenses, to a multiple (e.g., 2x, -2x) of the daily performance of its underlying benchmark (the "Daily Target"). For any holding period other than a day, your return may be higher or lower than the Daily Target. These differences may be significant.
