- Overweighting a market segment without additional cash

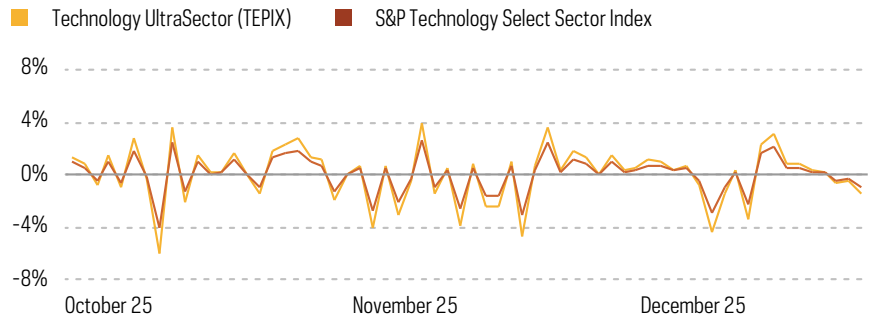

Daily return during 4Q 2025


