- Overweighting a market segment without additional cash

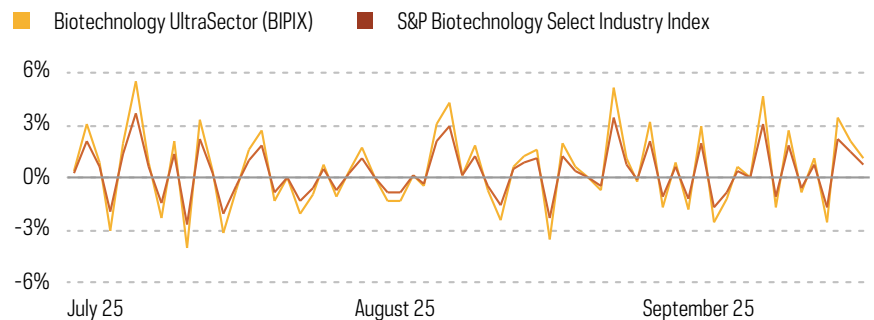

Daily return during 3Q 2025


