- Overweighting a market segment without additional cash

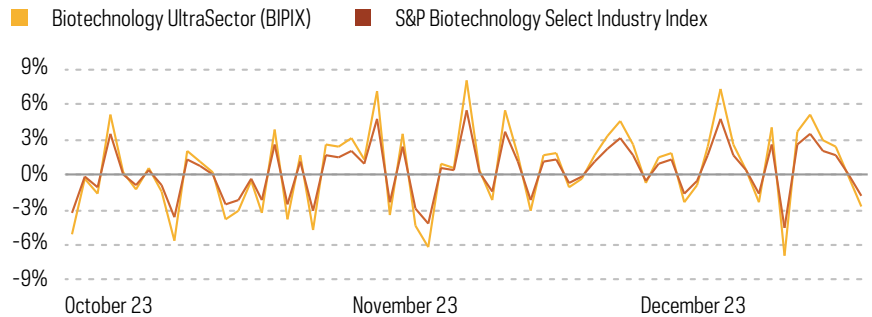

## Daily return during 4Q 2023


