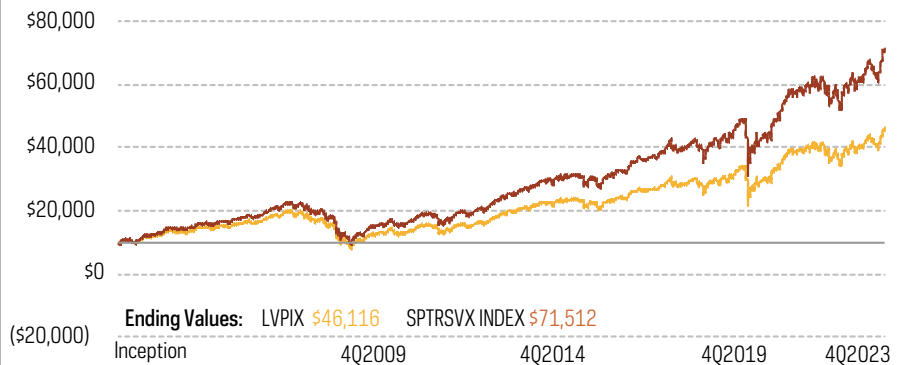

■ Large-Cap Value (LVPIX) ■ S&P 500 Value Index


